NOTICE IS HEREBY GIVEN that a special meeting of the Pasadena Redistricting Task Force will be held by video conference/teleconference on Saturday, October 16, 2021, at 9:00 a.m., to discuss the matters listed below.

- 1. CALL TO ORDER/ROLL CALL**
- 2. CONTINUED PUBLIC HEARING: PRESENTATION AND REVIEW OF DRAFT MAPS AND CONCEPTUAL REDISTRICTING PLANS, AND DIRECTION TO CONSULTANT ON PREPARATION OF REDISTRICTING PLAN(S) FOR CONSIDERATION \*\***

**Recommendation:** It is recommended that the Task Force:

(1) Find that the proposed action is exempt from the California Environmental Quality Act pursuant to State CEQA Guidelines, Section 15061(b)(3), the General Rule that CEQA only applies to projects that may have an effect on the environment;

(2) As part of the continued public hearing of the Task Force:

A. Receive and file the report from the Redistricting Ad Hoc Committee following their review of proposed conceptual redistricting map boundary changes and resulting impacts to City Council Districts 1, 2, 3, and 5;

B. Receive public input on communities of interest and/or recommendations and testimony regarding the composition of one or more council districts; and

C. Consider presented conceptual plans and provide direction to the Redistricting Consultant on the preparation of redistricting plan or plans to be considered for recommendation to the City Council;

(3) Continue the public hearing to each subsequent meeting of the Redistricting Task Force until October 30, 2021, or such other date as the Task Force may determine, at which time the Task Force will be asked to close the public hearing and approve a recommended redistricting plan or plans to submit to the City Council for consideration.

**Note to public:** *The City's Technical Consultant, National Demographics Corporation, has prepared draft maps that highlight redistricting concepts that were directed by the Redistricting Task Force for discussion purposes. These concepts will be discussed and considered but are not endorsed by the Task Force. Members of the public will be provided an opportunity to ask questions and provide public input and feedback on the conceptual plans.*
