CANDIDATE NOMINATION FILING PERIOD OPENS

02/14/22 Monday, February 14, 2022: Official Nomination Papers for City offices are available in the Office of the City Clerk, 100 North Garfield Avenue, Room S228, Pasadena. During the period of **February 14, 2022 through March 11, 2022**, both days included, candidates may circulate nomination petitions to gather signatures of registered voters for the following offices: City Council Districts 3, 5, and 7. In the event that the incumbent officer does not seek re-election or does not qualify through the nomination process, the deadline to circulate nomination petitions and file paperwork is extended to **March 16, 2022**.

03/09/22 - Opening of the Large Contribution and Expenditure Reporting Period (90
06/07/22 Days Prior to Election) – Filing deadline is within 24 hours of receiving
contributions of \$1,000 or more from a single source

CANDIDATE NOMINATION FILING PERIOD CLOSES

03/11/22 The Nomination Period for all of the above offices (where the incumbent
files nomination papers) closes on Friday, March 11, 2022, at 5:00 p.m.

03/16/22 Extended Nomination Period: If an incumbent officer for City Council does
not file, or files and does not qualify through the nomination process, the
nomination period is extended to Wednesday, March 16, 2022, at 5:00 p.m.,
for only that office and for only candidates other than the incumbent.

04/11/22 - Filing period for write-in candidates.

- 04/28/22 First Pre-Election Campaign Statement due for the period 1/1/22 – 4/23/22.
- 05/09/22 - Voters may request vote by mail ballots. May 9, 2022 is the first day
05/31/22 vote by mail ballots may be issued by the County. Voters may request vote by mail ballots through May 31, 2022.
- 05/23/22 Last day to register to vote. Same day voter registration is available at any Vote Center location in the County of Los Angeles.
- 05/28/22 - Vote Center Voting (in-person) will be available at designated locations
06/07/22 weekends and weekdays at any Vote Center located in the County of Los Angeles beginning Saturday, May 28, 2022 and continuing through Election Day, June 7, 2022. Hours of operation vary by location.
- 05/26/22 Second Pre-Election Campaign Statement due for the period 4/24/2022 – 5/21/2022.
- 05/31/22 Last day applications for vote by mail ballots may be received by the County Registrar of Voters. (Elections Code 3001)
- 06/07/22 ELECTION DAY** - Polls will be open from 7:00 a.m. to 8:00 p.m.
- 07/11/22 Primary Nominating Election results declared to the City Council.
- Any candidate receiving a majority of the total votes cast (50%+1) for a specified office in the Primary Nominating Election shall be declared elected, whose term will commence on December 12, 2022. Failing to receive a majority vote, the two persons receiving the highest number of votes in the Primary Nominating Election for each office shall be the only candidates for that office in the November 8, 2022 General Municipal Election. (Charter Section 1204)
- 08/01/22 Semi-Annual Campaign Statement due for the period 05/22/2022 through 06/30/2022 if filing obligations were incurred during this period.
