Viña Vieja Park – Turf Renovation of Off-Leash Area in Small Dog Area

The Department of Public Works will begin renovating turf in the small dog area of the Alice Frost Kennedy Off-Leash Area at Viña Vieja Park beginning Wednesday, June 4, 2014 and reopen to the public on Wednesday, July 15, 2014.

The small dog area will be temporarily relocated to the recently renovated southern section of the large dog area. This will allow small and large dog park users to have access to separate off-leash areas throughout the renovation project.

Turf renovations of the large dog area occurred in two phases – northern and southern sections – to allow users to have access to one-half of the large dog off-leash area at all times. Renovations included aerification, overseeding, fertilization, and time for seed germination. The northern section was completed and reopened to the public in April 2014. The southern section will open to the public on June 3, 2014.

The Department of Public Works has posted project information on site to alert park users of the upcoming turf renovation of the off-leash area in the small dog area.
