
## WEEKLY NEWSLETTER

## 1. VMT Metrics – Recent Activities:

Frederick C. Dock, Director of Transportation announced the December 2018 action by the State's Natural Resources Agency amending the CEQA Guidelines has completed the implementation of SB 743 and established the date of July 1, 2020 as the time by which cities will have to use Vehicle Miles Traveled (VMT) as the measure of transportation impact. The imminent requirement to use VMT has raised the interest level, both in the state and nationally, about cities currently using VMT metrics.

A recent publication by the Smart State Transportation Initiative (SSTI) and the Mayors Innovation Project, both based at the University of Wisconsin, Madison, highlighted Pasadena's use of VMT metrics. The report, *Modernizing Mitigation*, also looks at the efforts underway in San Francisco, San Jose, Oakland, and Los Angeles to develop and implement new transportation impact metrics.

SSTI recently requested and hosted a well-attended national webinar by Pasadena DOT on the City's experience with VMT metrics. That webinar is

# Zoning Code Amendments to Update Inclusionary Housing Requirements for Multi-Family Residential Projects and Establish an Affordable Housing Concession Menu for Density Bonus Projects

**PROJECT DESCRIPTION:** The Planning and Community Development Department is proposing a Zoning Code Amendment to make various changes to the City's inclusionary housing requirements, including changes to the percentage of inclusionary units required, the inclusionary in-lieu fee, and trade downs of affordable inclusionary units. Additionally, the Department is proposing a Zoning Code Amendment to the City's density bonus provisions establishing a menu of affordable housing concessions that would qualify for streamlined review for density bonus projects that meet certain criteria.

**PROJECT LOCATION**: All properties on which multi-family residential or mixed-use projects are an allowed use throughout the City of Pasadena.

**ENVIRONMENTAL DETERMINATION:** The Planning Commission will consider whether the proposed Zoning Code Amendments are exempt from the California Environmental Quality Act under Section 15305 (Class 5 – Minor Alterations in Land Use Limitations) and whether there are no features that distinguish this project from others in the exempt class; therefore, there are no unusual circumstances.

APPROVALS NEEDED: The Planning Commission will conduct a public hearing and consider the proposed Zoning Code Amendments on April 10, 2019. The Planning Commission will forward its recommendation to the City Council. The City Council will make a final decision on the proposed Zoning Code Amendments at a separately-noticed public hearing.

**NOTICE IS HEREBY GIVEN** that the Planning Commission will hold a public hearing to receive input from the public and provide comments on the proposed Zoning Code Amendments to update the City's inclusionary housing requirements and establish an affordable housing concession menu for density bonus projects.

### There will be no pre-bid meeting for this RFP.

Each Bidder must hold an active Class **A or B** License at the time of bid submission, except as to joint venture Bidders, who shall be licensed as provided in Business and Professions Code §§ 7029.1 and 7028.15(c).

Pursuant to the provisions of Section 1770 to 1782 of the California Labor Code, the California Department of Industrial Relations has ascertained the general prevailing rate of wages in the county in which work is to be done. A copy of the general prevailing rate of wages is on file with the City Engineer and is available for inspection and reference during regular business hours.

A contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code, or engage in the performance of this public works project unless currently registered and qualified to perform public work pursuant to Labor Code Section 1725.5. It is not a violation of Labor Code Section 1771.1 for an unregistered contractor to submit a bid that is authorized by Section 7029.1 of the Business and Professions Code or by Section 10164 or 20103.5 of the Public Contract Code, provided the contractor is registered to perform public work pursuant to Section 1725.5 at the time the contract is awarded.

This Project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

The Contractor must post job site notices prescribed by regulation (See e.g. 8 Cal. Code Reg. Section 16451(d).

Contractors and Subcontractors must furnish electronic certified payroll records directly to the California Labor Commissioner (aka Division of Labor Standards Enforcement).

All bids must be accompanied by bid security in the amount of five percent (5%) of the bid price, in the form of cash, cashier's check, money order, or surety bond.

Bids are to be signed and submitted in DUPLICATE. Bidder must submit bids with one ORIGINAL and one COPY, marked as such.
