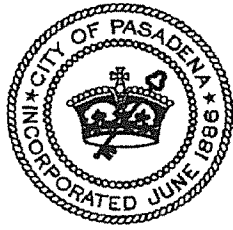

He also updated the Commission on the Red Light Contract and lastly the financial package for refinancing of the Arts Bus replacement fleet.


11. SUBCOMMITTEE REPORTS
