INFORMATION ITEMS FIRE DEPARTMENT STANDARDS OF COVERAGE

Calvin Wells, Fire Chief, provided an oral background overview of the City's Fire Department 2005 – 2010 strategic plan, staffing module, and responded to questions.

Stewart Gary, Consultant with Citygate Associates, LLC., provided a PowerPoint presentation of the results of the Standards of Cover study conducted, including policy choices, framework, performance review, risk assessment study results, field deployment strategy, multiple unit response, geographic findings, recommendations, next steps, options, and responded to questions.

Kevin Costa, Fire Bureau Chief, responded to questions regarding procedures on the transportation of paramedic patients and the possibility of a joint pilot study program with Los Angeles County Fire Department.

Michael Beck, City Manager, responded to questions regarding Fire Station 37 and the strategy of transporting patients to urgent care facilities.

Following discussion, the Committee, by consensus, requested that the item be presented to the City Council as an information item, and

directed staff to include the information regarding the pilot study program.

On the order of the Chair, and by consensus of the Committee, the information was received and filed.

PUBLIC COMMENT

Dennis McCoy, City of Tujunga resident, submitted correspondence and commented on the issuing of red light violation tickets at the intersection of Union St. and Marengo Ave.
