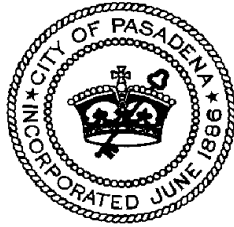

3. PUBLIC COMMENT ON MATTERS NOT ON THE AGENDA

Mr. Wes Reutimann spoke on behalf of Bike San Gabriel Valley and encouraged the City of Pasadena to follow the lead of Temple City with their Rosemead Boulevard Safety Enhancement and Beautification Project.

A. General Plan Land Use and Mobility Element Update – Preliminary review of the principles, objectives, and policies and draft Concept Land Use Map (Information/Review and Comment)

Jason C. Mikaelian, General Plan Manager, updated the Commission on the consolidated set of General Plan policy updates and a single concept land use plan. Since the last update to city Council on the General Plan in September

2011, staff has been continuing to elicit community feedback on the policies and refining a land use plan from four survey alternatives into one balanced concept. Feedback is needed before preparation for final recommendations to City Council. The Commissioners were allowed to ask questions and give their input.
