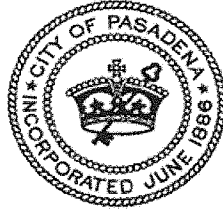
Documents or display boards submitted at the hearing become the property of the City of Pasadena.


