**4. PUBLIC HEARING: REGULAR CASES**

- A. Case No. A14-128285 Humane Society – 1725 Bridgen Road      Council District #4**

**Violations: Pasadena Municipal Code**

**General penalty – Pasadena Municipal Code Section 1.24.010(A):**

“No person shall violate or fail to comply with any provision or requirement of this code. Any person who violates or fails to comply with any provision or requirement of this code shall be guilty of a misdemeanor, unless (1) such a violation or failure is designated as an infraction or is subsequently prosecuted as an infraction, in which case such person is guilty of an infraction; or (2) such a violation or failure is prosecuted as a civil administrative action pursuant to Chapter 1.25 or Chapter 1.26 of this title.”

**Violations: Pasadena Municipal Code**

**Section 6.18.015 – (Prohibited Activities)**

“It is unlawful and a public nuisance for any person to own, harbor or keep a vicious dog”.

<sup>1</sup> Section 6.18.020(A)(9) P.M.C. states: “As used in this chapter, “public nuisance dog” or “vicious dog” means any dog that unreasonably annoys humans, endangers the life or health of other animals or persons, or substantially interferes with the rights of citizens, other than their owners or family members, to the enjoyment of life or property. The term “public nuisance dog” means and includes, but is not limited to, a dog who exhibits any of the following types of behavior: [9] Makes excessive and unprovoked disturbing noises, including, but not limited to, continued and repeated howling, barking, whining, or other utterances causing unreasonable annoyance, disturbance or discomfort to neighbors or others in close proximity to the premises where the animal is kept or harbored.” (emphasis added.)

**Recommended Commission Corrective Action:**

It is recommended that the Commission order Filiberto Ruiz to take the following corrective action within ten (10) calendar days from the mailing date of the Order of Code Enforcement Commission:

1. Obtain a bark control collar for "Cookie".
2. Ensure that "Cookie" wears a fully functional bark control collar at all times.
