AND SAFETY CODE SECTIONS 34181(a)(1) AND (f)**

**NOTICE IS HEREBY GIVEN** that the Oversight Board of the Successor Agency to the Pasadena Community Development Commission (“Oversight Board”) will hold a public meeting on Thursday, April 12, 2018, at 4:30 PM in the Economic Development Division Offices located on the 4<sup>th</sup> Floor, City Hall, City of Pasadena, 100 N. Garfield Avenue, Pasadena, California 91109, or as soon thereafter as the matter may be heard. The public meeting is being conducted in accordance with California Health and Safety Code Sections 34181(a)(1) and (f). The public meeting may be continued from time to time until completed. The public meeting may also be cancelled or set for another time in the future at any time until the scheduled meeting time.

The purpose of this public meeting is for the Oversight Board to consider the adoption of a Resolution authorizing the sale of an air parcel located at 135 North Los Robles Avenue, as listed as Item Number 2 on the approved Long Range Property Management Plan by the Successor Agency to DPPLF Land, LLC, a California limited liability company E-W Service AR, LLC, a California limited liability company. The Long Range Property Management Plan is available for viewing in the Economic Development Division Offices located on the 4<sup>th</sup> Floor, City Hall, City of Pasadena, 100 N. Garfield Avenue, Pasadena, California 91109, from 7:30 AM to 5:30 PM Monday through Friday.


