

**NOTICE OF PUBLIC HEARING**

**Project Location:** 1415 El Mirador Drive, Pasadena, CA

**Subject:** The applicants, Deven and Donald LeTendre, have submitted a Minor Variance application to allow a driveway gate and fence along the side (west) property line, ranging in height 6'0" to 7'4" within the front yard, where the maximum allowed height is four feet. A Minor Variance is required for a fence that exceeds the maximum allowable height.

**Environmental Determination:** This project has been determined to be exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (Public Resources Code §21080(b)(9); Administrative Code, Title 14, Chapter 3, §15303(e), Class 3, New Construction or Conversion of Small Structures), and there are no features that distinguish this project from others in the exempt class; therefore there are no unusual circumstances. Class 3 exempts from environmental review the construction of accessory structures including fences.

**NOTICE IS HEREBY GIVEN** that the **Hearing Officer may hold a public hearing** to consider the application if a request for one is made on the proposed application subject to the conditions indicated in the Public Information paragraph below.

If a hearing is not requested, the decision will be made without a hearing.**
