The purpose of the Human Relations Commission is to aid the city in achieving better human relations in city government, and to provide assistance to private persons and groups in promoting good will and better relations among all people. The Human Relations Commission is an advisory body.

OBJECTIVES:

1.	By June 31, 2019, conduct an Annual Meeting to review accomplishments for the FY2017-2018, member attendance for the year ended 6/30/19, and draft a work plan for FY2018-2019 (July 1, 2018 to June 30, 2019). STATUS:
2.	By August 31, 2019, submit to City Council an Annual Report of Accomplishments per the FY 2018-2019 Work Plan , a Commission Membership Attendance Report for the year ended 6/30/19, and a Work Plan for FY 2018-2019 (July 1, 2018-June 30, 2019). STATUS:
3.	To advise City Council on Human Relations issues of public, local and national concerns with regular updates to provide an opportunity to review and understand issues for the decision making process. STATUS:
4.	To present public forums, panels, and lectures on issues that affect human relations in the City of Pasadena.
