

**NOTICE OF PUBLIC HEARING**

**Project Location:** 1285 N. Michillinda Avenue, Pasadena, CA

**Subject:** The applicant, Richard F. Garris, has submitted a Minor Variance application to allow a 10-foot high fence feet between the occupancy frontage and the rear property line, where the Zoning Code limits height to six feet. A Minor Variance is required for a fence that exceeds the maximum allowable height.

**Environmental Determination:** This project has been determined to be exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (Public Resources Code §21080(b)(9); Administrative Code, Title 14, Chapter 3, §15303(e), Class 3, New Construction or Conversion of Small Structures), and there are no features that distinguish this project from others in the exempt class; therefore there are no unusual circumstances. Class 3 exempts from environmental review the construction of accessory structures including fences.

**NOTICE IS HEREBY GIVEN** that the **Hearing Officer may hold a public hearing** to consider the application if a request for one is made on the proposed application subject to the conditions indicated in the Public Information paragraph below.

However, the hearing will not be held unless a written request is submitted at least one business day prior to the hearing date. Any interested person may submit such a request at the Permit Center. If a hearing is not requested, the decision will be made without a hearing.**
