Project Location: 1035 East Green Street, Pasadena, CA

Subject: The applicant, Art Rodriguez Associates, has submitted a Conditional Use Permit application to allow the on-site sale and consumption of a full line of alcoholic beverages (beer, wine, distilled spirits) in conjunction with the operation of a restaurant (Taiji Restaurant). The site is located within the CD-5 LD-23 (Central District Specific Plan, Lake Avenue subdistrict, Green Street Village Landmark Overlay district) zone. A Conditional Use Permit is required for the on-site sale and consumption of alcohol in the CD-5 LD-23 zoning district.

Environmental Determination: This project has been determined to be exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (Public Resources Code §21080(b)(9); Administrative Code, Title 14, Chapter 3, §15301, Class 1, Existing Facilities) and there are no features that distinguish this project from others in the exempt class; therefore, there are no unusual circumstances. Section 15301 exempts the operation, permitting, licensing or minor alteration of existing structures where there is negligible or no expansion of the use. The sale of alcohol in conjunction with the operation of a restaurant use is considered a negligible expansion of a commercial use.
