

NOTICE OF PUBLIC HEARING

Project Location: 715 South Oak Knoll Avenue, Pasadena, CA

Subject: The applicant, Chiedu Chijindu on behalf of Sam Swabb, has submitted a Minor Conditional Use Permit application to allow the enlargement of a nonconforming use, where a nonconforming use may not be altered or enlarged unless a Minor Conditional Use Permit is first obtained. The project includes additions, totaling 1,214 square feet, to two existing dwelling units, and a 407 square-foot addition to an existing two-car detached garage. The subject site is located within the RS-6 (Single-Family Residential) zoning district, and is developed with two residential dwelling units, where the Zoning Code allows for one dwelling unit.

Environmental Determination: This project has been determined to be exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (Public Resources Code §21080(b)(9); Administrative Code, Title 14, Chapter 3, §15301, Class 1, Existing Facilities) and there are no features that distinguish this project from others in the exempt class; therefore, there are no unusual circumstances. Section 15301 exempts additions to existing structures, provided the addition will not result in an increase of more than 50 percent of the floor area of the structure before the addition or 2,500 square feet, whichever is less, and the project is in an area where all public services and facilities are available to allow for maximum development permissible in the General Plan, and the area in which the project is located is not environmentally sensitive.

However, the hearing will not be held unless a written request is submitted at least one business day prior to the hearing date. Any interested person may submit such a request at the Permit Center. If a hearing is not requested, the decision will be made without a hearing.**
