

**NOTICE OF PUBLIC HEARING

Project Location: 33 & 45 W. Green Street, Pasadena, CA

Subject: The applicant, Larry Mar, has submitted a Certificate of Exception application to allow a lot line adjustment that would consolidate two adjacent parcels into one parcel. No demolition of existing structures or new construction is proposed as part of this application.

Environmental Determination: This project has been determined to be exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (Public Resources Code §21080(b)(9); Administrative Code, Title 14, Chapter 3, §15305, Class 5, (Minor Alterations in Land Use Limitations); and there are no features that distinguish this project from others in the exempt class; therefore, there are no unusual circumstances. Section 15305 exempts minor alterations in land use limitations in areas with an average slope of less than 20 percent which do not result in any changes in land use or density, including but not limited to minor lot line adjustments. This request is limited to adjusting the property lines between adjacent parcels in an area with an average slope of less than 20 percent and no change in land use or density would result.
