Project Location: 288 Markham Place, Pasadena, CA

Subject: The applicant, John Gordon, has submitted a Minor Variance application to allow a front yard fence 3'10" in height, with a reduced setback of 7½" from the front property line, where the required setback is 18" from the front property line. The property is located within the RS-4-LD-9 (Single-Family Residential, Governor Markham Landmark District) zoning district. A Minor Variance is required for a front yard fence located within the 18" required setback.

Environmental Determination: This project has been determined to be exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (Public Resources Code §21080(b)(5); Administrative Code, Title 14, Chapter 3, §15270(a), Projects Which are Disapproved.
