Project Location: 320 E. Glenarm Street, Pasadena, CA

Subject: The applicant, Tom Lau, has submitted a Tentative Tract Map application to allow the creation of five air parcels on one land lot for residential condominium purposes. The new five unit residential project received Consolidate Design Review approval on January 29, 2018. This Tentative Tract Map application is for the creation of air parcels only. This application does not address the design or construction of the five-unit project and does not include any proposed changes to the previous Design Review approval.

Environmental Determination: In conjunction with the Consolidated Design Review approval on January 29, 2018, it was determined that the project is Categorically Exempt from CEQA (Section 15303, Class 3, New Construction or Conversion of Small Structures). It has further been determined that there are no changed circumstances or new information as part of the proposed Tentative Tract Map application that necessitate further environmental review and there are no features that distinguish this project from others in the exempt class; therefore, there are no unusual circumstances.
