I am writing as a parent of a PUSD student with my disapproval of PPD being placed into middle schools. And I am calling on the public safety committee and city council to intervene and deny the use of grant money to contract PPD for the Gang Resistance Education and Training Program.

There has been over 20 years of peer reviewed research that show that police in schools do not serve as a deterrent to violence or gang affiliation but instead place more young Black, Brown, and poor students into the School-to-Prison Pipeline.

In 2016 a study by criminologist at the University of Missouri St. Louis conducted research using over 7 years of data from the so called "GREAT" program and found it actually putting more young people into the criminal justice system. Even it's origins should call into question the impact of this program. It was created in

the early 1990s by the Phoenix Police Department and ATF. This is not a student, teacher, or counselor program, but instead a program to criminalize student and community.

Again I call on you to terminate contract with PUSD and PPD and instead invest in counselors, intervention workers, and other supports.

Comments (under 200 words)	Is this the first public presentation of the "GREAT" program? I find it odd that PPD comes to the Committee and the public AFTER the grant was secured, not before. We don't really know how the program has worked elsewhere.
	It doesn't sound like the kind of change in police work that the protests this summer were all about. Sure, police know about gangs, but are they the best professionals to talk with youth in school about it? Los Angeles Unified has recently said "no" to police in schools because of the "school to prison pipeline."

Around 2008, Martin Gordon, Michelle White and I worked with the School Board to remove police from the schools and require administrators to address behavioral problems. Now the PD wants them back. Is this the best use of police? Are they the best professionals to be educating youth about resisting gangs?

Why don't we delay the start to give the public and the Committee time to learn about the pros and cons of police educating, training and monitoring youth.

The "school to prison pipeline" is still a pipeline. Let's make sure we don't start it up again in PUSD schools.
