3. CERTIFICATE OF APPROPRIATENESS

A. 620 PRESCOTT ST - (COUNCIL DISTRICT 3)

Modifications to the front entry door, publicly visible windows, and exterior siding of a contributing property to the Craftsman Heights Landmark District.

(Case Planner: R. Pelayo) Applicant/Owner: Frances Bono

Public Comment: A. Salimian

Commission Comments:

- The design of the new front entry door and sidelights shall be revised to be consistent with the larger glazing proportions found in traditional designs.
- The proposed door shall be painted, stained, or covered with a clear protective coating to protect it against the elements to maximize its longevity.
- The center window of the tripartite street-facing and driveway-facing windows shown for "bedroom 105" of the floor plan shall have a single-light in the middle to match the design of the living room window facing the street.
- The headers of the two new window openings along the west elevation shall align with those on the existing street-facing windows to maintain a consistent height.
- The original exterior siding on the north and east elevations shall be retained and repaired unless it is damaged beyond repair. Documentation shall be submitted for staff review to determine whether its condition warrants replacement. In addition, any original wood siding that is removed to accommodate the new door and windows shall be repurposed to the greatest extent possible.

The project shall be subject to final site inspection and sign-off by staff of the Design &
Historic Preservation section to ensure that the work plan undertaken, as described
above, is as indicated and specified in the decision letter and that all work is performed
consistent with the approved plans and the Guidelines for Historic Districts.
