**3. LANDMARK DESIGNATION**

**A. 371 PATRICIAN WAY – (COUNCIL DISTRICT 6)**

Designation of the property at 371 Patrician Way as a landmark pursuant to Pasadena Municipal Code (PMC) Section 17.62.040 because it is the embodiment of the work of an architect whose work is locally significant. The property is an example of a Spanish Revival style single-family residential estate designed by William F. Staunton of Webber, Staunton & Spaulding, Architects.

Staff Recommendation:

1. Find that the designation of a historic resource is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15308, Class 8 pertaining to Actions by Regulatory Agencies for Protection of the Environment such as designation of historic resources.
2. Recommend that the Historic Preservation Commission forward a recommendation to the City Council to approve the designation of the property at 371 Patrician Way as a landmark.
