I live at 585 Avocado Ave, bordering the Vina Vieja Park, where pickleball courts are planned south of the dog park. In our neighborhood we are already impacted by dog park patrons driving through and parking in our streets. We're concerned that there be no vehicular access to the park from Avocado Ave, either temporarily during construction, or permanently for park patrons (there is currently a pedestrian gate). We are also concerned that there doesn't seem to be increased parking planned inside the park for phase 1 construction. Without this, there will certainly be increased traffic and park patrons' cars surrounding our houses. Please include extra parking spaces inside the park as a precondition to opening any pickleball courts.

- The Initial Study is quite clear that vehicle access will be only from Orange Grove Blvd. That is good. Opening vehicle access from Avocado Ave would be strongly opposed, as it would bring destination traffic through our neighborhood streets. Please add to the Conditional Use Permit a condition prohibiting opening vehicle access between Avocado Ave and the park.
- The Initial Study's "Potential Project Construction Phasing" includes parking in its Phase A, but it is not clear that the details of the phasing plan must be adhered to. Please add a condition that any initial phase must include sufficient on-site parking for park users.
