REGULAR CASES

A. CUP #6863: 3026 EAST ORANGE GROVE BOULEVARD – COUNCIL DISTRICT #4

Conditional Use Permit: To allow the expansion of a 'Park and Recreation Facility' use (Viña Vieja Park) in order to facilitate the construction of 12 pickleball courts and related facilities on an undeveloped area south of the existing park. A Conditional Use Permit is required for the expansion of a 'Park and Recreation Facility' in the OS (Open Space) zoning district.

Staff Recommendation:

- 1) Adopt the Mitigated Negative Declaration; and
- 2) Approve the Conditional Use Permit with conditions.

B. CUP #6884: 3475 EAST COLORADO BOULEVARD – COUNCIL DISTRICT #4

Conditional Use Permit: To allow a 3,061 square-foot addition to the front of an existing auto dealer showroom. A Conditional Use Permit is required for a Vehicle Services – Sales and Leasing use within the ECSP-CG-6 (East Colorado Specific Plan, General Commercial, Sub-area 6) zoning district.

Staff Recommendation:

- 1) Find that the project is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15301 (Class 1, Existing Facilities); and
- 2) Approve the Conditional Use Permit with conditions.


