Subject: The applicant, Burke Farrar, on behalf of the property owner, has submitted a Vesting Tentative Tract Map application for the creation of 42 air parcels for residential condominium purposes and one air parcel for commercial condominium purposes on one land lot. The associated mixed-use project was granted Affordable Housing Concession Permit #11866 on July 16, 2018, and obtained Concept Design Review approval on September 11, 2018. This application is limited to the creation of air parcels to allow the individual sale of the commercial space and dwelling units. This application does not address the design or construction of the 42-unit project and does not include any proposed changes to the previous Affordable Housing Concession Permit or Design Review approvals. The subject property is located within the CD-3 (Central District Specific Plan, Walnut Housing subdistrict) zoning district.

Environmental Determination: In conjunction with the Affordable Housing Concession Permit approval on July 16, 2018, it was determined that the project is Categorically Exempt from CEQA (Section 15332, Class 32, In-Fill Development Projects). It has further been determined that there are no changed circumstances or new information as part of the proposed Vesting Tentative Tract Map application that necessitate further environmental review and there are no features that distinguish this project from others in the exempt class; therefore, there are no unusual circumstances.

NOTICE IS HEREBY GIVEN that the Hearing Officer will hold a public hearing to consider the application.
