1. ADVANCE CORRESPONDENCE, TO BECOME PART OF THE RECORD:

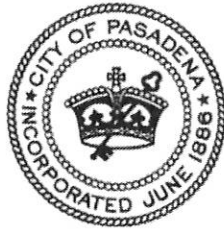
