

**NOTICE OF PUBLIC HEARING**

**Project Location:** 3840 Fairmeade Road, Pasadena, CA

**Subject:** The applicant, Heather Grant, property owner, has submitted a Neighborhood Development Permit application to allow façade improvements and the construction of a 38 square-foot single story addition to front of an existing 2,153 square-foot, one-story, single-family residence with a 484 square-foot detached garage. The property is located in the RS-6-ND (Single-Family Residential, Neighborhood Development Overlay) zoning district. A Neighborhood Development Permit is required for any building addition visible from a public right-of-way.

**Environmental Determination:** This project has been determined to be exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (Public Resources Code §21080(b)(9); Administrative Code, Title 14, Chapter 3, §15301, Class 1, Existing Facilities) and there are no features that distinguish this project from others in the exempt class and, therefore, there are no unusual circumstances. Section 15301 exempts additions to existing structures, provided the addition will not result in an that will not result in an increase of more than 10,000 square feet provided the project is located in an area where all public services and facilities are available to allow for maximum development permissible in the General Plan, and the area in which the project is located is not environmentally sensitive. The proposed addition to an existing single-family residence would occur in areas that are not environmental sensitive, where public services and facilities are available, and would be consistent with the General Plan and Zoning Code.
