

NOTICE OF PUBLIC HEARING

Project Location: 1133 and 1137 Arden Road, Pasadena, CA

Subject: The applicant, Dr. Amber Tyson, has submitted a Certificate of Exception application to allow a lot line adjustment between two adjacent parcels at 1133 Arden Road (APN: 5327-012-022) and 1137 Arden Road (APN: 5327-012-023). The proposed lot line adjustment would reconfigure a shared interior lot line, removing 2,304 square feet from 1137 Arden Road and allocating it to 1133 Arden Road. No demolition, new construction, or tree removal is proposed with this application. The parcel at 1133 Arden Road is located within the RS-4-LD-28 (Single-Family Residential, 0 – 6 dwelling units per acre, Arden Road Landmark Overlay) zoning district and 1137 Arden Road is located within the RS-4 (Single-Family Residential, 0 – 6 dwelling units per acre) zoning district.

Environmental Determination: This project has been determined to be exempt from environmental review pursuant to the guidelines of the California Environmental Quality Act (Public Resources Code §21080(b)(9); Administrative Code, Title 14, Chapter 3, §15305, Class 5, Minor Alterations in Land Use Limitations) and there are no features that distinguish this project from others in the exempt class; therefore, there are no unusual circumstances. Section 15305 exempts minor lot line adjustments, in areas with an average slope of less than 20 percent, which do not result in any changes in land use or density. The proposal will adjust an interior lot line between two adjacent parcels, will not result in a greater number of parcels than originally existed, and does not result in any changes in land use or density. The proposed lot line adjustment is therefore exempt from environmental review.

NOTICE IS HEREBY GIVEN that the **Hearing Officer** may hold a **public hearing** to consider the application if a request for one is made on the proposed application subject to the conditions indicated in the Public Information paragraph below.
