Mission:

The purpose of the commission is to advise the council on accessibility issues in Pasadena. The commission shall:

1. Study and examine: (a) existing inequities in access to the physical, work, communication, civic involvement, social and cultural environments for all residents of Pasadena, particularly those who have disabilities, and (b) policies, procedures, programs, and legislation for eliminating those inequities.
2. Recommend policies, procedures, programs, and legislation to promote and ensure the accessibility of the physical, work, communication, civic involvement, social and cultural environments to all residents of Pasadena, particularly those who have disabilities; and
3. Consult and cooperate with other public agencies and commissions on matters relevant to the commission.

Objective Purpose: Advise and inform the City Council on accessibility issues

Work Plan Updates

July 2023:

- The Adaptive Sports Festival has been confirmed for Saturday, November 4, 2023, at Brookside Park. Sara Goldman is working with Eric Lomeli and Triumph Foundation to plan the festival.

August 2023:

- Commissioner Jagusch provided the following updates on the action items for the objective:
 - The City will be requesting public comment on the North-South Greenways project in Fall 2023 and recommended the Commission receive a presentation from the Department of Transportation regarding an update on the project prior to the date for public comment.
 - The Commission will make a recommendation in January 2024 on the accessibility improvements in the public right-of-way and the installation of curb ramps. She requested the Commission receive a presentation from the Department of Transportation regarding an update on the current accessibility improvement projects.
 - Reminded the Commission of the date for the Adaptive Sports Festival and to plan on assisting on the day of the event at the commission table to share information about the work of the Commission with the community.

September 2023:

- Chair Jennings shared comments from Cy Estabrook regarding the upcoming Adaptive Sports Festival (ASF) and reminded Commissioners to plan on assisting on the day of the event at the commission table to share information about the work of the Commission with the community. Chair Jennings reminded Commissioners to invite their respective Councilmembers to the ASF.
- Commissioner Jagusch was approved to speak on behalf of the Commission at the 10/10/2023 meeting of the Municipal Services Committee regarding the North-South Greenways project.

October 2023:

- Commissioner Jagusch provided the following updates on the action items for the objective:
 - Municipal Services Committee discussed “All Ages and Abilities” design criteria for North-South Greenways on 10/28/2023.
 - Reminded the Commission of the date for the Adaptive Sports Festival (ASF) and to plan on assisting on the day of the event at the commission table to share information about the work of the Commission with the community.
- Staff Goldman to send sign-up information for Commissioners for ASF tabling.

November 2023:

- The Commissioner discussed formalizing honoring the Robert Gorski Access Award recipient each year at the annual Pasadena Adaptive Sports Festival. The Commission will vote to approve this at the January 2024 regular meeting.

December 2023:

- Meeting cancelled

January 2024:

- Commissioner Jagusch reported the ad hoc committee met on Monday, January 22 and discussed the following items:
 - Monitoring California Assembly Bill 1757 titled Accessibility: internet websites, to determine how it will affect the community.
 - The status of the Commission recommendations for Capital Improvement Program (CIP) projects.
 - Researching how the Commission can support local businesses regarding accessibility issues and will add an action item to the objective, if appropriate.
- Staff (Goldman) reminded the Commission to report concerns about accessibility at crosswalks, with street signal timing or with Pasadena Transit to the Citizens Service Center either online, through the app or by calling (626) 744-7311 and to include that the request is an accessibility issue.
- The ad hoc committee deemed the following action item completed: Support and promote the annual Adaptive Sports Festival.

February 2024:

- Commissioner Jagusch reported the ad hoc committee met on Thursday, February 22 and discussed the following items:
 - Researching available resources for local businesses to address accessibility issues.
 - Concerns about the availability of accessible parking on Union Street and researching the definition of accessible parking on residential streets.

March 2024:

- Commissioner Jagusch reported the ad hoc committee met on Sunday, March 17 and discussed the current City policies regarding overnight parking passes for residents of Accessory Dwelling Units (ADU's). The ad hoc committee requested Staff (Goldman) arrange a meeting with the Department of Transportation to share concerns regarding accessible parking for disabled residents.
- Staff (Goldman) shared that the Planning Department is currently evaluating the parking policy for ADU's and will provide updates to the ad hoc committee when available.

- Commissioner Herrera provided the following update on the EmployAbility Grants webinar:
 - The webinar is scheduled for Thursday, August 24, 2023, at 10:00 A.M.
 - The flyer for the webinar will be sent to the Commission once it is finalized and requested the Commission distribute the flyer to their networks.
 - The ad hoc committee has contacted the local Department of Rehabilitation office to encourage their support and attendance at the webinar.

August 2023:

- Commissioner Jagusch provided the following updates on the action items for the objective:
 - The ad hoc committee will begin to review the criteria and nomination process for the Robert Gorski Award and present the information to the Commission at an upcoming meeting.
 - Announced the Annual Pasadena Civitan Reception recognizing local businesses committed to hiring individuals with disabilities is on Thursday, October 12, 2023, from 5:00 – 7:00 P.M. at AbilityFirst, Pasadena.
 - Encouraged the Commission to attend the Planning Commission Study Session regarding the Lamanda Park Specific Plan on Wednesday, August 23, 2023, at 6:30 P.M. This is a good opportunity to learn about development plans in the City and provide public comment to promote inclusion of individuals with disabilities in the plans. The Commission received an email on Monday, August 21 with more information about the meeting.
- Chair Jennings reported she assisted at the commission table at Assemblymember Chris Holden’s Annual Community Resource Fair and Block Party on Saturday, August 5, 2023, and shared information about the work of the Commission with the community.
- Commissioner Herrera reported 50 local businesses have registered for the EmployAbility Grants webinar scheduled for Thursday, August 24, and encouraged the Commission to register for the event to learn more about the program.
- Commissioner Warner II reported he attended the iBook Club virtual meeting on Monday, August 14, with 15 participants in attendance. During the meeting, the participants shared their favorite music recordings in a variety of media formats. The Commission will be sent the iBook Club newsletter with information about the virtual meeting scheduled for September 11.

September 2023:

- Commissioner Jagusch reminded the Commission about supporting the Annual Pasadena Civitan Reception recognizing local businesses committed to hiring individuals with disabilities is on Thursday, October 12, 2023, from 5:00 – 7:00 P.M. at AbilityFirst, Pasadena.
- Chair Jennings stated that the ad hoc committee will begin to review the criteria and nomination process for the Robert Gorski Award and present the information to the Commission at an upcoming meeting.
- Commissioner Herrera reported that the EmployAbility Grant Webinar was successful, and a recording of the webinar is available through the City’s Economic Development web page.
- The Commission requested follow up with Department of Rehabilitation regarding outcome reporting including numbers of applications and successful grant awards by webinar attendees.

October 2023:

- Staff and Commissioners shared experiences from the Annual Pasadena Civitan Reception honoring Pasadena Humane, Armstrong Nurseries, Chuck E. Cheese, Huntington Dining Services, and YMCA of the Foothills for their commitment to hiring and accommodating individuals with disabilities. Commissioners voiced appreciation for Civitan, AbilityFirst, and Villa Esperanza.
- Commissioner Herrera provided the following updates on the action items for the objective:
 - The ad hoc committee will continue to review the criteria and nomination process for the Robert Gorski Access Award and present the information to the Commission at the November regular meeting.
 - The Department of Rehabilitation will provide information about the individuals who have applied for and/or received EmployAbility grant funds following the Pasadena workshop.
- Commissioner Warner II reported he attended the iBook Club virtual meeting on Monday, October 9, with 8 participants in attendance. The topic was “Unusual Places People Live.” Participants discussed interesting places they have lived in the past. Next month, the iBook club will meet on November 13 at 3 pm. The topic will be “Explorers,” with a presentation from a rocket scientist.

November 2023:

- The Commission discussed the nomination process for the Robert Gorski Access Award, including whether to accept nominations from community-based organizations rather than solely from Commissioners. The Commission will vote to confirm the process at the January 2024 regular meeting.
- Commissioner Herrera provided the following updates:
 - 7 local businesses from Pasadena have been awarded the EmployAbility grant, with more details regarding awards to be reported in January.
- Commissioner Warner II reported that the iBook Club met on November 13, 8 members were present, and they discussed world exploration.

December 2023:

- Meeting cancelled

January 2024:

- The Commission approved the Nomination Process and Criteria for the 2024 Robert Gorski Access Award.
- Commissioner Herrera requested that all Commissioners nominate an individual for the Robert Gorski Access Award during the nomination period from March 1 – 30, 2024. She recommended that Commissioners request suggestions from their networks if they do not know an individual that meets the criteria.

- Commissioner Jagusch stated that the list of Pasadena agencies that support people with disabilities seeking employment is being reviewed and updated by the ad hoc committee to ensure the agencies are notified of employment opportunities within the City.
- Chair Jennings asked Staff (Goldman) about how the Commission can provide input on job descriptions for positions that may include accessibility awareness within the scope of duties. Staff (Goldman) stated she will research the request and provide an update at the meeting scheduled for February 27.
- Commissioner Warner II reported he attended the iBook Club virtual meeting on Monday, January 8, with 9 participants in attendance. The topic was “Interesting Facts.” Next month, the iBook club will meet on Monday, February 5 at 3:00 p.m. since the library is closed on Monday, February 12 and 19.
- The ad hoc committee deemed the following action items as completed:
 - Support the Civitan event honoring employers of people with disabilities and disseminate information about employers supporting the hiring of people with disabilities.
 - Promote awareness of the Department of Rehabilitation “Demand Side Initiative” and EmployAbility grants for businesses to support employment for individuals with disabilities.
- The ad hoc recommended adding the following action item to the objective:
 - Facilitate a town hall style meeting around the topic of accessible housing in Pasadena.
- Chair Jennings removed Commissioner Jagusch, at her request, from the Outreach and Education ad hoc committee.
- Chair Jennings appointed Commissioner Struski to the Outreach and Education ad hoc committee.

February 2024:

- Chair Jennings thanked the Commissioners that assisted at the commission table at the Black History Festival on Saturday, February 17 and the Commissioners shared their experience of sharing the work of the Commission with the community.
- Commissioner Herrera reported the ad hoc committee met on Monday, February 26 and discussed the following items:
 - Created a draft agenda for the town hall style meeting to get feedback from the community regarding accessible housing in Pasadena.
 - Drafted a Save the Date flyer for the meeting to send to Staff (Goldman) for review.
 - The nomination process for the Robert Gorski Access Award and reminded the Commission the nomination period is from March 1 – March 30.
- Commissioner Struski shared a comment she received from a resident at the Black History Festival regarding the concern of small business owners being fined by the City for non-compliance of accessibility standards based on private citizens filming their place of business.

- Staff (Goldman) stated she will research the concern with the appropriate City department and provide an update at the meeting scheduled for March 26.

March 2024:

- Commission Herrera stated the ad hoc committee has received two nomination forms for the Robert Gorski Access Award and will present their recommendations at the meeting scheduled for April 23.
- Vice Chair Warner II reported that the iBook Club met on March 11, with 11 members in attendance, and they discussed their favorite movies that were based on books. The next iBook Club meeting is Monday, April 8 and the topic is Earth Day.
- Staff (Goldman) provided the following information regarding the planned town hall style meeting regarding accessible housing in Pasadena.
 - Date and time: Thursday, May 30, 2024, from 7:00 – 9:00 P.M.
 - Location: City Council Chamber at City Hall.
 - The meeting will be covered live by KPas and be held in-person and virtually.
 - Sign Language interpretation will be provided.
 - Marketing will be coordinated with the Public Information Office including the creation of a flyer and press release.
- Commissioner Herrera reviewed the proposed agenda for the meeting and stated Interior Designer Jeanne Chung is confirmed as the Keynote Speaker.
- Commission attendance at the town hall style meeting was discussed to determine if the event will replace their regular meeting scheduled for Tuesday, May 28. Staff (Goldman) will verify the meeting options with the City Attorney and provide the information to the Commission at their meeting scheduled for April 23.
- Staff (Goldman) shared three upcoming community events that provide an opportunity for the Commission to staff a resource table and share information about the work of the Commission including the upcoming town hall event:
 - Pasadena Unified School District (PUSD) Community Advisory Committee Resource Fair on Saturday, April 27 from 10:00 A.M. – 1:00 P.M. at 351 S. Hudson Avenue, Pasadena.
 - Pasadena Public Health Department's Spring Into Wellness on Saturday, May 4 from 11:00 A.M. – 3:00 P.M. at Villa Parke Community Center.
 - Pasadena Celebrates Older Americans Month on Wednesday, May 22 from 10:00 A.M. – 1:00 P.M. at Victory Park.
- The Commission will discuss the options for having a resource table at one of the recommended events at their meeting on April 23.

Ad Hoc Committee re: Objective #3 – Health, Wellness, and Inclusive Community

Objective Purpose: To prioritize accessibility measures in public safety, housing, and community health.

Commissioners: Heinrich (Lead), Warner II, Jennings

Action Items:

- Facilitate communication with Pasadena Public Health Department regarding best practices pertaining to authentic disability inclusion.
- Work collaboratively with Department of Housing to increase availability of affordable and accessible housing.
- Ensure a training program that prioritizes accessible measures in public safety is added to the current public safety training manual.

Work Plan Updates:

July 2023:

- Chair Jennings reported that the ad hoc committee is developing a comprehensive list of accessible features that can be used in the development plans for building or remodeling homes, apartments, office buildings, City facilities or public places that that will provide accessibility to individuals with visible or invisible disabilities. A draft of the list will be presented to the Commission at a future meeting and requested the Commission gather suggestions for features to include on the list from friends, family, and individuals within their networks.

August 2023:

- Commissioner Heinrich reported the ad hoc committee met on Monday, August 21 and discussed ways the Commission can assist in educating the community about the need for affordable and accessible housing.
- The ad hoc committee recommends the Commission receive a presentation from Ethan Wolferman, Senior Homeowner Advisor, Cottage ADUs, regarding the importance of accessibility in Accessory Dwelling Units (ADUs).
- Commissioner Herrera reported she will contact Jennifer Estep, Training Coordinator, Pasadena Police Department, to request an update on the recommendation to implement mandatory crisis intervention training for all police officers to improve police interactions with people with disabilities and provide an update to the Commission at the September meeting.

- Staff (Souto) reported he will follow up to arrange the presentation for the Commission from Ron Takiguchi, Building Official, Planning and Community Development Department regarding an update on the City's Prototype Design Options for Accessory Dwelling Units (ADUs).
- Commissioner Heinrich recommended the Commission receive a presentation regarding state and local building codes pertaining to accessibility in residential housing.

September 2023:

- Staff provided the Commission with the opinion from the State Attorney General to state and local building departments regarding responsibilities/requirements and authority pertaining to accessible housing.

November 2023:

- Chair Jennings presented a draft comprehensive list of accessible features that can be used in the development plans for building or remodeling homes, apartments, office buildings, City facilities or public places that that will provide

- accessibility to individuals with visible or invisible disabilities. The Commission and staff discussed the draft and City policies regarding the release and promotion of the final document. Discussion will be continued at the January 2024 regular meeting.
- Commissioner Herrera provided the following update:
 - Discussions are continuing with Pasadena Police Department (PD) regarding the adoption of crisis intervention training. Jennifer Estep requested that the Accessibility and Disability Commission connect PD with local community partners to work with to better understand the needs of the disability, access, and functional needs community.

- Staff (Goldman) reported that Manuel Carmona, Interim Director of the Department of Public Health would like to make a presentation to the Commission regarding the Language Access work group that has developed guidelines for the City to provide accessible communication to the community that includes both primary language and mode of communication.

- The ad hoc committee requested Commission Herrera follow up with Jennifer Estep, Training Coordinator to request an update on the recommendation to implement mandatory crisis intervention training for all police officers to improve police interactions with people with disabilities.
