Pasadena has four measures on the June Primary Ballot.

Two measures (AA and BB) are proposed amendments to the City Charter which would move election dates for City Council and Pasadena Unified School District Board of Education from odd years to coincide with state and federal elections in even years to be consistent with the California Voter participation Rights Act (CVPRA). The measure regarding the Board of Education will also consolidate the current primary-general election into a single plurality election.

The two other measures (CC and DD) pertain to the regulation and taxation of commercial cannabis businesses in the City of Pasadena. One measure would allow the limited cultivation, retail sales, and testing of commercial cannabis in the City of Pasadena. The second cannabis measure will impose a tax on commercial cannabis businesses operating in the City of Pasadena.
