

## Elder Abuse Cross Reporting

SOC 341





Pasadena currently has 16 Skilled Nursing Facilities (SNFs) and 33 Residential Care Facilities for the Elderly (RCFEs) in the city limits. As Law Enforcement Officers we are mandated under the Welfare and Institutions Code to cross-report any dependent adult or elder abuse allegations to multidisciplinary teams having statutory authority. Pasadena Police Policy 326.3- Adult Abuse Investigations and Reporting: *All reported or suspected cases of adult abuse require investigation and a report, even if the allegations appear unfounded or unsubstantiated.* In an effort to stay the course with the mandate of the Welfare and Institution Codes, all incidents of neglect or abuse at SNFs and RCFs, even if unfounded, will be documented with a GO number, to include a written narrative and SOC-341. It will then be the officer's responsibility to cross report these incidents before end of watch.

Failure to report, or impeding or inhibiting a report of abuse of an elder or dependent adult, is a misdemeanor (Welfare and Institutions Code §15630(h)).
