The City of Pasadena is not responsible for lost, late, destroyed, incomplete, unreadable, corrupted, or misdirected entries; Internet malfunction; server unavailability; or computer malfunction.

Videos may not use the name or logo of the City of Pasadena, the Pasadena Public Health Department, or any other organization without the organization's express, written consent.

By participating in the contest, participants are bound by the decisions of the City of Pasadena. The City of Pasadena reserves the right to disqualify any submissions (a) depicting graphic sexual activity, (b) depicting the drinking of alcohol, (d) depicting the use of tobacco and other drug products, firearms/weapons, any activities that may appear unsafe or dangerous, or any behavior which would be illegal if committed by a person under 18 years of age, or (e) containing content deemed by the City of Pasadena, in their sole and absolute discretion, to be obscene, offensive, or slanderous.

Any false information provided in connection with the contest by any participant may result in elimination of the entry from the contest.

Neither the contest entry submitted by me or my child, nor any portion thereof, infringes on any copyright, any rights of privacy or publicity of any person, or any other right of any third party.

THE CITY OF PASADENA reserves the right to disqualify any entry that it believes infringes or violates the rights of any third party, does not comply with the Official Rules, or violates applicable federal, state or local laws. The City of Pasadena may refuse to award any prize to a person who has violated any Contest Rule, gained an unfair advantage in participating in the contest, or obtained winner status using fraudulent means. The City of Pasadena will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the contest and City decisions concerning such disputes shall be final. If the conduct or outcome of the contest is affected by human error, any mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, intentional interference or any event beyond the control of the City of Pasadena, the City of Pasadena reserves the right to terminate this contest or make such other decisions regarding the outcome as the City of Pasadena deems appropriate. (Collectively, "Materials"), for documentary, promotional, educational, or other lawful purposes. This may include use of the Materials in any manner or medium that THE CITY OF PASADENA deems appropriate, such as, but not limited to, radio broadcasts; newspapers and other publications; television or film releases; slides; videotape; and distribution over the Internet.

In addition to the foregoing, I grant THE CITY OF PASADENA the right to edit, prepare derivative works of, modify, and otherwise make use of my or my child's contest entry for documentary, promotional, educational, or other lawful purposes and in any manner or medium that THE CITY OF PASADENA deems appropriate.

I may rescind the consent provided in the two immediately preceding paragraphs regarding the Materials at any time if compliance with that request is not unreasonably burdensome to the City or unlawful. I also understand that rescission of my consent will not affect any uses of the Materials that have occurred before I notify THE CITY OF PASADENA of my decision to rescind consent. I understand that, to rescind my consent, I must do so in writing, signed, and delivered to the Public Information Officer of the Pasadena Department of Public Health at 1845 N. Fair Oaks Ave, Pasadena, CA 91103.

I, and each of my respective heirs, successors, and assigns, waive, release, forever discharge and covenant not to make a claim against or sue the Contest Sponsor, the Contest Administrator, or any of Contest Sponsor's or Contest Administrator's employees, agents, officers, directors, representatives, successors or assigns (collectively, the "Hosts") for any claim, liability, loss, injury or damage arising out of, or in connection with the contest entry, The 2022 #VaccinatePasadena Video Contest, or use of the Materials as described above. I agree to indemnify and hold harmless the Hosts from and against any liabilities, losses, claims, injuries, damages, demands, costs (including, without limitation, reasonable attorneys' fees) and expenses arising out of or in connection with my or my child's participation in the Contest.
