RE: Public Records Act Request

Pursuant to my rights under the California Public Records Act (Government Code Section 6250 et seq.), I ask to obtain a copy of the following, which I understand to be held by or under the control of your agency.

- 1) Copies of all documents (including but not limited to emails, correspondence, CUP applications, meeting notes) sent to or received from Harvest of Pasadena LLC or any person or entity representing itself as acting on Harvest of Pasadena LLC's behalf.
- 2) Copies of all documents relating to the scoring of the Harvest of Pasadena LLC application in the possession of the city or in the possession of third parties under the city's control including documents held by HDL Companies including but not limited to drafts, scoring notes, selection committee notes or reports and emails.

- 3) Copies of all emails received by or sent by any city employee or public official mentioning any cannabis related matter from January 1, 2019 through the date of production.
- 4) Copies of all emails sent by or received by Guille Nunez from November 1, 2018 through the date of production.
- 5) Copies of all material generated by any member of the cannabis selection/interview committee relating to the selection/interview/application process.
- 6) Copies of all emails sent by or received by Nicholas Rodriguez from the following individuals for the period beginning June 1, 2019 through the date of production:

- 8) Copies of all emails sent to or received from Richard McDonald to any city employee or official from November 1, 2018 through the date of production.
- 9) All materials relating to the production, presentation and use of the City's draft cannabis map.
- 10) Any and all documents including internal emails regarding the status of the private non-profit Rudolf Steiner library located at 110 Martin Alley, Pasadena, CA including but not limited to business license information and other permit documents and emails discussing the library's status are it relates to cannabis zoning.

11) Any documents including staff reports or minutes of any meetings regarding the definition under the Pasadena Municipal code of a library.

I ask for a determination on this request within 10 days of your receipt of it, and an even prompter reply if you can make that determination without having the records in question.

If you determine that any or all of the information qualifies for an exemption from disclosure, I ask you to note whether, as is normally the case under the Act, the exemption is discretionary, and if so whether it is necessary in this case to exercise your discretion to withhold the information.

If you determine that some but not all of the information is exempt from disclosure and that you intend to withhold it, I ask that you redact it for the time being and make the rest available as requested.

In any event, please provide a signed notification citing the legal authorities on which you rely if you determine that any or all of the information is exempt and will not be disclosed.

If I can provide any clarification that will help expedite your attention to my request, please contact me at 626-354-4550. I ask that you notify me of any duplication costs exceeding \$300 before you duplicate the records so that I may decide which records I want copied.

Thank you for your time and attention to this matter.
